Matthew was living in Lynn, Massachusetts in 1636 and he was a tailor, on March 9, 1637 he was made a freeman. In 1646 he removed to Newport, Rhode Island, and was made a freeman. There on January 16, 1677, he deeded grandson, "Nathaniel West for love, and ect., son of my oldest son, Nathaniel West, who departed this life many years ago and forasmuch as he hath for many years past and now dose live with me, and his comfort of me in my old age dwelling house I now live in by (bounded) by John Crandall and John Thornton, immedialty after my deccase"

and being of sound and perfect mind and memory do  
make and publish this my last will and testament In  
manner and form following hereby revoking all former  
will or will by me made and this only to be taken as my  
last will and testament. First I desire that i may be buried  
in a decent and Christian manner at the direction  
of my Executor and that all my lawful debts and

funeral expenses be first paid Secondly I desire that all and every my Estate both real and personal be sold by public vendue my wearing apparel only except and the sale to be made within two years after my decease as my Executor may think more advantageous Thirdly I will and desire that there be made an equal division of all and every of the arrangement-of the sale of my estate and the interest of each and every ones proportion to be paid them from the day of sale till they receive their proportion paid Namely James Radcliffe Phebe Cadwallader Johnathan Radcliffe Isaiah Radcliffe Rebeca Hough Rachel Nelans and Joseph Radcliffe and I desire that my wearing apparel may be equally divided as my Executors sees more equal among my four sons above mentioned and lastly I appoint my two sons namely James Radcliffe and Jonathan Radcliffe Executors in witness where of I have here unto set my hand and seal this twelfth day of January one thousand seven hundred and eighty eight.
